- You **must** make an application, even if you have **an elder child** attending your preferred school.
- **The order** in which you the schools is **only used** if you could be offered more than one school. In this case, you would be offered whichever of those schools was highest on your application.
- **Understand** the admissions criteria for each of your preferences, this will enable you to assess what order of priority will be given for each preference.
- You should consider how your child will get to school, very few children are entitled to free home to school travel assistance.
- You must consult with any other persons who have parental responsibility for this child.
